TO SUBMIT A CLAIM FOR PAYMENT:

- 1. Read all documents contained in this Notice Packet.** Your legal rights may be affected whether you act or don't act.
- 2. Complete and Sign the Claim Form.** Your signature confirms that the information you provide is true and correct. Unsigned Claim Forms will be denied. All information is subject to verification for accuracy by the Claims Administrator.
- 3. Provide Supporting Documentation.**
 - If you own your residence and the ownership status of the property site address listed above is correct, no additional documentation is needed to show your ownership status. If your ownership status shown above is incorrect, and you are/were the owner, additional documentation is required to support your ownership status. Please see the Documentation Guidance section for more information. **Regardless of the ownership status shown above, you must submit a Claim Form to receive compensation.**
 - If you occupied a residence (including as an owner or a tenant) you must provide documentation to establish your residency. Please see the Documentation Guidance section for more information.
- 4. Submit the completed Claim Form.** You must mail the completed Claim Form and supporting documentation to the address at the top of this page, **postmarked no later than February 11, 2022.**

DOCUMENTATION GUIDANCE:

All documents submitted will be maintained confidentially and used strictly for settlement purposes.

- 1. Ownership Documentation:** Property Owners can demonstrate ownership by providing any one (1) of the following:
 - a. A closing statement,
 - b. A mortgage statement (redacted to remove dollar amounts), or
 - c. A property tax statement.
- 2. Residency Documentation (Owner/Occupant):** For a property owner that resides at the property located in the Class Area, you can show your residency by providing any one (1) of the following:
 - a. A utility bill showing your name, the residential address, and a date within the Class Period, or
 - b. A driver's license or state identification card issued by the State of Texas showing your name and address.
- 3. Residency Documentation (Non-owner Tenant or adult occupant):** For a tenant or adult occupant that resides at the property located in the Class Area, you can show your residency by providing any one (1) of the following:
 - a. A lease agreement identifying the property address at issue with the term of the lease,
 - b. A letter from the property owner or leasing agent acknowledging the address and dates of occupancy and identifying you as the tenant or an individual with a right to reside at the residence.
 - c. A utility bill showing your name, the residential address, and a date within the Class Period, or
 - d. A driver's license or state identification card issued by the State of Texas showing your name and address
- 4. For supporting documentation submissions, only the portions of the document that includes your name, the property address, the date, and all completed signatures are required.**
